### **Results from Spring Members' Survey**



RCN undertook membership survev which was carried out online and closed on Friday 26 February 2021. 39 responses were received, response rate οf 15.6%. The survey

was designed to ask groups about some of the key issues they were facing to carry out their work. It also asked them about key priorities in rural Northern Ireland as we recover from the effects of the pandemic. Some of the headline findings were:

- We asked respondents to rank the top three concerns in their community. The top three concerns were firstly health and well-being, second broadband and third community development.
- Respondents were also asked about what the NI Executive should prioritise as they develop the Programme for Government and to help people recover following the pandemic. A wide range of responses were received but investing in health and mental health. rolling out rural broadband connectivity more quickly and supporting grass roots community groups were key priorities.
- Almost 75% of respondents said that they had adapted their work to deliver to local communities due to the pandemic and would either return to what they had been doing or adapt their work using knowledge and experience gained during the pandemic. respondents reported concern that they had been unable to adapt their work during the pandemic and were unsure how to get re-started again.

A longer report on the findings of the survey will be emailed to members in the coming weeks and we would be happy to hear feedback from our members on the findings.


